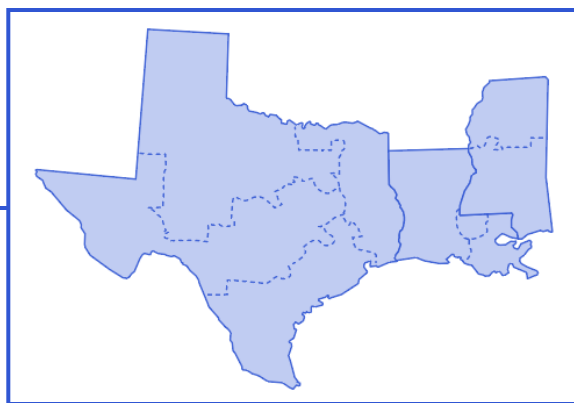




Introduction
